Statement of Evidence:

Meander Corner #27 on the East line of Section 1, Township 140 North, Range 29 West, Woodrow Township, 5th Principal Meridian, Cass County, Minnesota.

Original US General Land Office survey by Johnson and Thornton, set a wood post and bearing trees noted as:

6" Willow S 17° E 22 links 8" Cedar S 53° W 40 links

- Survey notes of Robert F. Schneider, RLS 5740, showed a 1 ¼" iron pipe found on the shore of Woman Lake. Mr. Schneider's records contained a survey by Harold Curo, RLS No. 3417, dated March 8, 1961 which showed an iron monument at this location. Curo's survey also shows an iron at the North 1/16th corner of Section 1 and Section 6. Mr. Schneider extended these irons north to intersect the 10th Standard Parallel and found this computed position to fit very well with the GLO distances. The distance from the Southwest Standard Corner of Section 31, Township 141, Range 28 to the computed intersection was found to be 757.75 feet compared to GLO distance of 759.0 feet. Intersection to iron found at Meander Corner #27 was found to be 858.61 feet compared to GLO distance of 858.0 feet. Mr. Schneider accepted the in-place iron as marking the meander corner position and based metes and bounds surveys in Government Lot 10, Section 6, Township 140, Range 28 on the found iron monument. In 1971, Mr. Schneider conducted additional surveys in Section 6 involving the Subdivision of Section 6. (Entry derived from Corner Certificate No. 302547)
- 1977 Walt Curo shows corner in place on sketch, filed in Curo Book 258, Page 156.
- 1988 Gary Stevenson, Registered Land Surveyor Number 12684, found 1 ½" I.P. Set 2x2x36" monument with aluminum cap. Steel sign post north 1.25', filed Corner Certificate No. 302547, dated February 3, 1988. Reference ties:

Westwood Professional Services, Inc. found 1988 aluminum capped monument and two 1988
Stevenson Reference Ties. Located found monument with a 20 minute static GPS shot and verified coordinates with VRS GPS observation. Analysis of the recovered data, field evidence and survey measurements, indicates that the monument found by Westwood Professional Services, Inc is the best available evidence for this corner.
