

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 5th day of September, 1963, I found the Center West corner of section 26 which was evidenced by a 2" diameter iron pipe from a survey by Cass County Surveyor James H. Flynn in 1921.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter 60" long galvanized steel monument capped with a 3" diameter bronze tablet stamped:

T142N R26W
W 1/16C — S 26 — C
1963
R.L.S. No. 6807

from which reference or witness monuments are located in the manner following:

Maple 6" N18°W 22.2 feet scribed CW 1/16 S 26 BT

Maple 6" S25°W 34.0 feet scribed CW 1/16 S 26 BT

Steel sign post 72" long due west 3.6 feet with signs 54-2 and 54-4 attached.
