



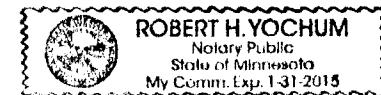

AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 20th day of August, 1963, I found the Center East 1/16 corner of Section 26 which was evidenced by a 1 1/2 diameter iron pipe from a survey by Cass County Surveyor James H. Flynn in 1921.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter 60" long galvanized steel monument filled with concrete and capped with a 3" diameter bronze tablet stamped:-

from which reference or witness monuments are located in the manner following:
