





William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 23rd day of August, 1963, I found the south 1/16 corner of sections 26 - 27 which was evidenced by a 2" diameter iron pipe from a survey by Cass County Surveyor James H. Flynn in 1921.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter, 60" long galvanized steel monument filled with concrete and capped with a 3" diameter bronze tablet stamped:-
