

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 17th day of September, 1963, I found the Quarter corner of Sections 10 - 11 which was evidenced by 1 1/2" diameter iron pipe identified by local resident as a perpetuated corner by County Surveyor.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of 2" inside diameter 60 inch long galvanized steel pipe filled with concrete and capped with a 3 inch diameter bronze tablet stamped:-
