



William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 29th day of July, 1966, I found the Meander corner of Sections 1-36 which was evidenced by remains of original Government survey of 1872 Squared scribed post

Cedar 6 inch N3°E 5.28 feet - Now burned stump N3°E 5.8 feet with faint scribe visible

Also a 1 inch diameter pipe set along side scribed post.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2 inch inside diameter 5 foot long galvanized steel pipe filled with concrete and capped with a 3 inch diameter bronze tablet stamped.
