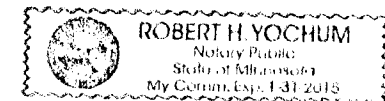

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 12th day of March, 1964, I found the Section corner of sections 20-21-28-29 which was evidenced by remains of the original government survey of 1871

Cedar 16" N20°E 14 links 9.2' - Found cedar stump with scribe "BT" visible.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of 2 inch inside diameter 60 inch long galvanized steel monument filled with concrete and capped with a 3 inch diameter bronze tablet stamped:-
