That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.......

I further depose and say that on the 13th day of January , 19 64, I found the Angle point 2-3 corner of Section 28
which was evidenced by a monument set by the G.L.O. resurvey of 1918, which is a 1 inch diameter iron post with brass cap stamped:

TR 1340 S28 TR 1584 AP2 TR 1345 1918

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as the G.L.O. brass cap is in good condition.
