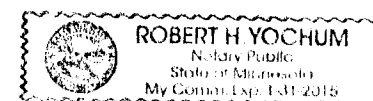

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 3rd day of September, 1963, I found the Quarter corner of sections 11 - 14 which was evidenced by remains of the original government survey of 1872

Norway Pine 8" N75°E 9 links (5.94') now partly decayed stump at record bearing and distance.

2 inch iron pipe identified as one set by County Surveyor J. H. Flynn from original bearing trees by Clarence Van Atta local resident.

Cedar post-believe to be an original, with scribe marks visible.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of 6 inch diameter, 60 inch long cylindrical concrete monument, capped with a 3 inch diameter tablet stamped:-

T142N N26W  
 1/4 S 11  
 S 14  
 1963

from which reference or witness monuments are located in the manner following: R.L.S. No. 6807

Birch 9 inch S57°E 45.3 feet scribed 1/4 S 14 BT
