





William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 23rd day of August, 1967, I found the East 1/16 corner of Sections 20 - 29 which was evidenced by remains of the G.L.O. resurvey of 1917, consisting of 1 inch diameter iron pipe 3 feet long with brass cap stamped: E 1/16 S20 S29

Found brass cap in shoulder of road 4.00 feet below surface.

N. Pine 8 inch N46°E 7.26 feet - now 17 inch N46° 8.30 feet

N. Pine 5 inch S62 3/4°W 18.43 feet - not found, falls in road right-of-way and clearing.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as G.L.O. monument is in good condition.
