





AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 16th day of December, 1965, I found the Special Meander corner of Section 22

which was evidenced by remains of the G.L.O. resurvey of 1913 consisting of 1 inch diameter iron post, 3 feet long with brass cap marked:

Found brass cap approximately 1000 feet from corner.

Poplar 8 inch N61°W 21.78 feet - not found

Poplar 6 inch S39°W 17.16 feet - not found

found a 2 inch diameter iron pipe 2 feet long set by Synder

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6 inch diameter cylindrical concrete monument 2 feet long capped with a 3 inch diameter bronze tablet stamped:
