



Peter J. Meyer; being first duly sworn, deposes and says:
 That I reside at Cass Lake, Minn., and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628
 I further depose and say that on the 21st day of January, 1964,
 I found the Angle Point 5 corner of Section 21 which was evidenced by the iron post with brass cap set by the General Land Office Survey of 1918 - brass cap is stamped:
 AP 5
 TR
 1385
 No bearing trees were marked. 1918

Angle point 5 is 9.94 chains East from the Quarter corner of Sections 20 and 21.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new monument set as the GLO brass cap was found to be in good condition.
