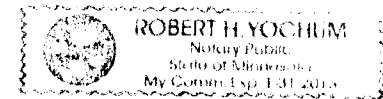

, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minn., and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 21st day of January, 1964, I found the Center West 1/16 corner of Section 21 which was evidenced by the remains of the GLO survey of 1918.

1 inch diameter iron post with a brass cap stamped: C $\frac{W 1/16}{S 21}$ C
 1918

Red Pine 5 inch S7°E 41 links or 27.06 feet (Now a 1 1/4 inch red pine at record bearing and distance).

Red Pine 5 inch N35 1/4°W 60 links or 39.6 feet (Now a 1 1/4 inch red pine at record bearing and distance).

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new monument set as the GLO brass cap is in good condition.
