



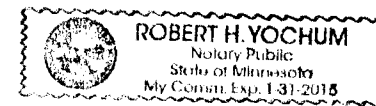

William H. Okerman, being first duly sworn, deposes and says:
That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.
I further depose and say that on the 27th day of August, 1963, I found the Quarter corner of sections 22 - 23 which was evidenced by the remains of a survey by Cass County Surveyor, J. H. Flynn and deputy E. E. Horst in 1916.

Red Pine 8" N25°E 31.7 (Now a 16" Red Pine with scribe
¼ S 23" visible at record bearing and distance

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6" diameter 60" long Cylindrical Concrete Monument capped with a 3" diameter bronze tablet stamped

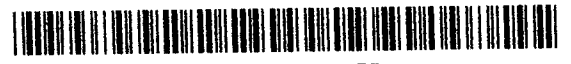
