



## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

William H. Okerman, being first duly sworn, deposes and says:  
That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.  
I further depose and say that on the 23rd day of September, 1963, I found the Section corner of 19-20-29-30 which was evidenced by a 4"x4" Cedar post with scribe marks visible at record bearing and distance from tag of T. H. Williams Location checks with original running notes.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter galvanized steel monument filled with concrete and capped with a 3" diameter bronze tablet stamped:-
