





AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 17th day of September, 1963, I found the Section corner of Sections 22-23-26-27 which was evidenced by remains of a survey by Cass County Surveyor James H. Flynn, and Dept. E. B. Horst, in 1921, White pine stump 5' high S60°W 36.3' (Now a partly burned pine stump scribed "S 27 BT" at record bearing and distance) White pine stump S62°E 12.0' (Now a badly burned pine stump at record bearing but 16.0 feet) found a 2½"x4" iron monument in place

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of 2" inside diameter 60" long galvanized steel monument filled with concrete and capped with a 3" diameter bronze tablet stamped:-

T142N R26W

S 22	S 23
S 27	S 26

from which reference or witness monuments are located in the manner following:

Rock 2'x2'x6" S34°W 25.8' X Chiseled on top

Rock 2'x2½'x1' N03°W 34.2' X Chiseled on top

Steel sign post 72" long 2½" in ground due north 2.8 feet with signs 54-2 and 54-4 attached.
