



AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

William H. Okerman, being first duly sworn, deposes and says:
That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.
I further depose and say that on the 18th day of September, 1963, I found the Quarter corner of sections 1-36 which was evidenced by an iron pipe 1 1/2" diameter set by J. A. Gjelhaug, Civil Engineer

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter 60" long galvanized steel monument filled with concrete and capped with a 3" diameter bronze tablet stamped:-

from which reference or witness monuments are located in the manner following:

Red Pine 5" S15°E 22.2 feet scribed X BT
