





WILLIAM H. OKERMAN, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 24th day of September, 1963, I found the West 1/16 corner of Sections 5 - 8 which was evidenced by the remains of a survey by Cass County Surveyor J. H. Flynn in 1920, recorded in record book "C" pages 386-387.

Scribed post alongside old fence post.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter 60" long galvanized steel monument filled with concrete

and capped with a 3" diameter bronze tablet stamped: T11 1/2 N R26 W
