





William H. Okerman, being first duly sworn, deposes and says:
 That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.
 I further depose and say that on the 21th day of September, 1964, I found the Quarter corner of sections 5 - 8 which was evidenced by 2 inch iron pipe set by Cass County Surveyor Flynn in 1920 while subdividing section 8.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of 2 inch inside diameter 60 inch long galvanized steel monument capped with 3 inch diameter bronze tablet stamped:-
