





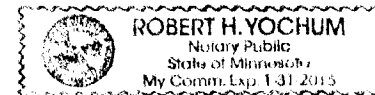

## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

WILLIAM H. OKERMAN, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 24th day of September, 1963, I found the Northwest 1/16 corner of Section 8 which was evidenced by the remains of a survey by Cass County Surveyor J. H. Flynn in 1920, recorded in record book "C" Pages 386-387.

Found a scribed post marking corner.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6" diameter 60" long cylindrical concrete monument capped with a 3" diameter

bronze tablet stamped: T112N R26W  
 NW 1/16 S8  
 1963  
 R.L.S. No. 6807

from which reference or witness monuments are located in the manner following:

Oak 20" S31°W 24.9 feet scribed NW 1/16 S8 BT

Twin Oak 14" N53°E 64.1 feet scribed NW 1/16 S8 BT

Cedar Post 4"x4"x60" with red top due north 2.8 feet with signs 54-2 and 54-4 attached.
