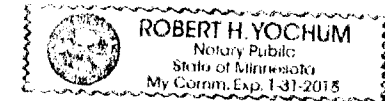

## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Quarter

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 21st day of October, 1963, I found the Quarter corner of Sections 7 - 8 which was evidenced by the remains of a survey by J. Flynn Cass County Surveyor in 1920.

Norway Pine 10" S40°E 45.5' (Found pine stump at record bearing and distance).

Pine stump 8" N13°W 14.0' (in field)

This corner was identified by Mr. Pohl, settler of the farm in 1914 who was shown the original bearing trees by Flynn. Pohl then set his fence corner at the location, and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of 2" inside diameter 5' long galvanized steel monument, filled with concrete and stamped:-

from which reference or witness monuments are located in the manner following:

Red Pine 5" S72°E 86.7 feet scribed X BT

Birch 5" S14°W 39.5 feet scribed 1/4 S 7 BT
