That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 20th day of November, 1964, I found the Closing corner of Sections 5-6 which was evidenced by remains of a survey by John M. Greene, County Surveyor in 1923.

Iron monument - found a 2 inch diameter iron pipe at corner.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2 inch inside diameter 5 feet long galvanized steel pipe filled with concrete and capped with a 3 inch diameter bronze tablet stamped.
