 That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.
 I further depose and say that on the 15th day of June, 1964, I found the Quarter corner of Sections 3-34 which was evidenced by remains of a survey by Cass County Surveyor J. H. Flynn in 1922.
