William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 5th day of November, 1968, I found the Section corner of Sections 9-10-15-16 which was evidenced by remains of the G.L.O. resurvey of 1919 consisting of 2 inch diameter iron pipe 3 feet long with brass cap marked TL41N R27W Found iron with brass cap knocked off S9|S10 N. Pine 24 inch N22°E 93.0 feet - found bruned stump at record bearing S16|S15 and distance.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of 6 inch diameter 2 foot long cylindrical concrete monument capped with a 3 inch diameter brass tablet stamped
