William H. Okerman, being first duly sworn, deposes and says:
That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.
I further depose and say that on the 24th day of June, 1968, I found the Section corner of Sections 10-11-14-15 which was evidenced by C.C.C. notes of R.T. DeFant in 1941. Found iron pipe in good condition 5 inches below road surface - found pipe as described.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6 inch diameter 2 foot long cylindrical concrete monument capped with a 3 inch diameter brass tablet stamped


