William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 8th day of September, 1969, I found the Center North 1/16 corner of Section 17 which was evidenced by remains of the G.L.O. resurvey of 1919 consisting of 1 inch diameter iron post 3 feet long with brass cap marked

W. Oak 18 inch N36°45'E 54.12 feet - now a burned stump at record bearing and distance

W. Oak 12 inch S67°E 79.86 feet - now a 16 inch at record bearing and distance


and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as G.L.O. monument is in good condition.


