



William H. Okerman, being first duly sworn, deposes and says:
That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.
I further depose and say that on the 6th day of June, 1969, I found the Section corner of Sections 15-16-21-22 which was evidenced by remains of the G.L.O. resurvey of 1919 consisting of 2 inch diameter iron pipe 3 feet long with brass cap marked
N. Pine 20 inch N65°W 41.6 feet - found snag at record bearing and distance.
