William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 25th day of August, 1969, I found the Quarter corner of Section's 22 - 27

which was evidenced by remains of original Government survey of 1874.

N. Pine 18 inch N80°W 56.1 feet - found burned stump

N. Pine 20 inch S40°W 51.5 feet - found burned stump at record bearing and distance with scribe marks visible

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2 inch diameter 5 foot long galvanized steel pipe filled with concrete and capped with a 3 inch diameter brass tablet stamped
