William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 5th day of October, 1966, I found the South East 1/16 corner of section 7 which was evidenced by remains of the G.L.O. resurvey of 1919 corner was found to be marked by a 1 inch diameter iron pipe with brass cap stamped

J Pine 10 inch N75°E 23.10 feet (now a 16 inch N75°E 23.10 feet scribe overgrown) SE 1/16 S7 1919
J Pine 10 inch S9°W 18.48 feet (now a 11 inch S9°W 18.48 feet scribe overgrown)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No. new monument set as the G.L.O. brass cap is in good condition.
