That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 20th day of June, 1969, I found the South 1/16 corner of Sections 7-8

which was evidenced by remains of the G.L.O. resurvey of 1919 consisting of 1 inch diameter iron post 3 feet long with brass cap marked -
found 14 inches below road surface
