

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 3rd day of January, 1966, I found the Quarter corner of Sections 15 - 16 which was evidenced by remains of the G.L.O. resurvey of 1918, consisting of 1 inch diameter iron post, 3 feet long with brass cap stamped:

S16 | S15
1/4
1918

Found post as described.

Oak 12 inch S66°E 36.30 feet - now 21 inch at record bearing and distance.

Oak 6 inch N72°W 38.28 feet - not found

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as G.L.O. monument is in good condition.
