

Peter J. Meyer, being first duly sworn, deposes and says:
 That I reside at Cass Lake, Minn., and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628
 I further depose and say that on the 23rd day of January, 1964, I found the Quarter corner of Sections 16 - 21 which was evidenced by a monument and two bearing trees from the GLO resurvey of 1918 -
 A 1 inch diameter iron post with brass cap stamped: $\frac{1}{4}$ S 16 S 21 1918
 Pine 32 inch N22 3/4°E 38 links or 25.08 feet (Now a 34 inch white pine at record bearing & distance).
 Oak 6 inch S43 1/4°W 75 links or 47.5 feet (Now a decayed stump at record bearing & distance).
 and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No. new monument set as the GLO brass cap is in good condition.

from which reference or witness monuments are located in the manner following:

White oak 9 inch S 27 1/2°W 81.35 feet scribed 1/4 S 16 BT
 Red Oak 10 inch N79°W 69.9 feet scribed 1/4 S 21 BT
 Steel sign post 72 inches long, set 24 inches in ground with F.S. Standard signs 54-2 and 54-4 attached due west 4.7 feet.
