

Peter J. Meyer, being first duly sworn, deposes and says:
 That I reside at Cass Lake, Minn., and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.
 I further depose and say that on the 20th day of January, 1964, I found the East 1/16 corner of Sections 16 - 21 which was evidenced by the remains of the General Land Office survey of 1918. Corner was found to be marked by a 1 inch diameter iron post with a brass cap stamped: E 1/16 S 16 S 21 1918
 Pine 12 inch N57 $\frac{1}{2}$ °E 84 links or 55.44 feet (Now a 20 inch red pine N61°E 55.44 feet).
 Pine 6 inch S48°E 146 links 04 96.36 feet (Now a 17 inch red pine S45°E 97.3 feet).

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new monument set as the GLO brass cap is in good condition.

from which reference or witness monuments are located in the manner following:

Re-scribed the two GLO red pine bearing trees with the letters "BT".

Steel sign post 72 inches long, set 24 inches in ground with signs 54-2 and 54-4 attached due East 4.2 feet.

All reference bearings are true bearings.
