William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 17th day of December, 1965, I found the West 1/16 corner of Sections 15 - 22 which was evidenced by remains of the G.L.O. resurvey of 1918 consisting of 1 inch diameter iron post, 3 feet long with brass cap marked:

Found post as described

S22
1918Oak 6 inch N55°E 36.30 feet - now 9 inch at record bearing and distance with scribe overgrown.
Elm 6 inch S52°W 23.10 feet - not found
