William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6307.

I further depose and say that on the 17th day of December, 1965, I found the quarter corner of Sections 15 - 22 which was evidenced by remains of the G.L.O. resurvey of 1918 consisting of 1 inch diameter iron post, 3 feet long with brass cap marked:
