Peter J. Meyer , being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota , and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 22nd day of January ,19 64, I found the Northwest 1/16 corner of Section 21

which was evidenced by the remains of the GLO survey of 1918.

A 1 inch diameter iron post with a brass cap stamped: NW 1/16 S21

was found marking corner. 1918

Poplar 6 inch S 1 3/4°E 40 links or 26.4 feet (Now a aspen stump 12" at record bearing and distance).

Poplar 5 inch S25°W 44 links or 29.06 feet (Now a aspen stump 12" at record bearing and distance).

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of \_\_\_No new monument set as the GLO brass cap is in good condition.
