



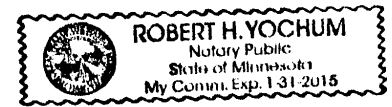

AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

SMC on the re-established original meander line 11.22 chains south of the West 1/16
 Corner to Sec. 8-17 T. 141 N R. 29 W No. 311

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 27th day of August, 1964, I found the special meander corner of section 17 which was evidenced by the remains of the G.L.O. resurvey of 1918.

Corner was found to be marked by a 1 inch diameter iron post with a brass cap stamped:-

Maple 1 1/4 inch N55°30'W 42 links (27.72') (now a 1 1/2 inch maple at record bearing and distance with blaze facing corner)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as the G.L.O. brass cap is in good condition.

Steel sign post 72" long N74 1/2°E 5 feet with Forest Service signs 54-2 and 54-4 attached.
