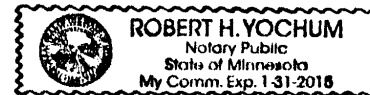

AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

S.M.C. on the reestablished original meander line 27.25 chains north of the center east

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 15th day of February, 1963,

I found the special meander corner of section 18

which was evidenced by the remains of the GLO resurvey of 1918.

Corner was found to be marked by a 1 inch diameter iron post with brass cap stamped:

Cedar 12 inch N21°30'E 76 links (50.16') (Now a 13 inch cedar scribed "S18" at record bearing and distance.)

Tamarack 9 inch N37°45'W 65 links (42.9') (Now a decayed stump at record bearing and distance.)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new monument set as the GLO brass cap is in good condition.

from which reference or witness monuments are located in the manner following:

Cedar 6 inch N73½°E 6.67 feet marked SMC BT

Steel sign post 72 inches long, set 24 inches in ground with F.S. signs 54-2 and 54-4 attached due south 3.8 feet.

All reference bearings are true bearings.
