







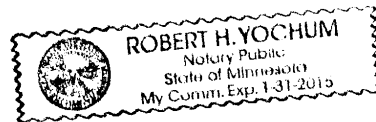

## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Center North 1/16

Corner to Sec. 17 T. 141N R. 29W No. 212

Peter J. Meyer, being first duly sworn, deposes and says:  
 That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 14th day of February, 1963, I found the Center North 1/16 corner of Section 17 which was evidenced by the remains of the G.L.C. survey of 1918.

Corner was found to be marked by a 1 inch diameter iron post with brass cap stamped:—  
 Spruce 7 inch S24°E 39 links (25.74') (Now a spruce stub with scribe marks visible S24°E 28.38 feet.)  
 Red oak 16 inch N24°W 43 links (28.38') (Now a 19 inch oak partly dead N24°W 25.74 feet.)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No. new monument set as the G.L.C. brass cap is in good condition.

from which reference or witness monuments are located in the manner following:

Maple 6 inch S25°W 4.65 feet marked ON 1/16 BT

Maple 4 inch N87°E 18.9 feet marked X BT

Steel sign post 72 inches long, set 24 inches in ground, with standard signs 54-2 and 54-4 attached due south 6.15 feet.

All reference bearings are true bearings.
