

AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 14th day of February, 1963,

I found the special meander corner of Section 17 which was evidenced by the remains of the G.L.O. resurvey of 1918.

Corner was found to be marked by a iron post 1 inch diameter with a brass cap stamped:-

Maple 9 inch S76°E 71 links (46.86') (Now a maple stump at record bearing and distance.)

Angle point 8 S3°13'W 2.12 chains or 139.92 feet as reported

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new monument set as the G.L.O. brass cap is in good condition.
