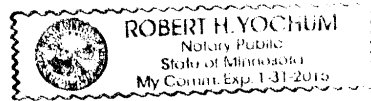

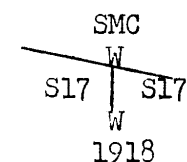
William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 24th day of July, 1963, I found the Special Meander corner of section 17 which was evidenced by remains of the G.L.O. resurvey of 1918. Corner was found to be

marked by a 1 inch diameter iron pipe with brass cap stamped

Aspen 10 inch S33°E 53 links (Now a 14 inch Aspen S33°E 34.98 feet scribe overgrown)



Aspen 10 inch S48°W 44 links (Now a 19 inch Aspen S48°W 29.04 feet scribe overgrown)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No. new monument set as the G.L.O. brass cap is in good condition.

from which reference or witness monuments are located in the manner following:

Maple 5 inch N16°W 15.2 feet scribed SMC BT

Maple 6 inch S5°W 8.8 feet scribed SMC BT

steel sign post 72 inches long set 24 inches in ground with signs 54-2 and 54-4 attached S66°E 4.0 feet
