

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 14th day of February, 1963, I found the Angle Point 10 corner of Section 17 which was evidenced by remains of the G.L.O. resurvey of 1918. Corner was found to be

marked by a 1 inch diameter iron pipe with brass cap stamped

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new monument set as the G.L.O. brass cap is in good condition.
