



That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 21st day of June, 1965, I found the Closing corner ~~of~~ on the E 1/16 line Section 27 which was evidenced by the remains of the G.L.O. resurvey of 1918

Corner was marked with a 1 inch diameter iron post marked

N Pine 6 inch N28°15'E 17.82 feet (Now a stump N28° 17.82 feet)

N Pine 8 inch N49°W 49.50 feet (Now a 20 inch N Pine N49°W 49.0 feet)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new monument set as old one is in good condition.
