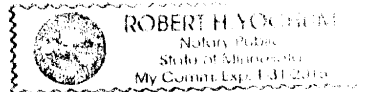

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 21st day of October, 1964, I found the Closing corner of the Indian Reservation Boundary which was evidenced by the remains of the G.L.O. resurvey of 1918. Corner marked by an iron post 3 feet by 1 inch stamped

N Pine 8 inch N19°E 13.86 feet (Now a rotten stump with scribe visible)
