

AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 8th day of October, 1964, I found the Section corner of sections 29 - 30 - 31 - 32 which was evidenced by remains of original government survey of 1873 Post - scribed

Tamarack 4 inch S63°W 7.26 feet (Now a decayed stump)
 Tamarack 4 inch S56°E 13.20 feet (Now a decayed stump)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2 inch inside diameter 5 feet long galvanized steel pipe filled with concrete and capped with a 3 inch diameter bronze tablet stamped
