









## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Corner to Sec.s 28 - 29 - 32 - 33 T. 141N R. 29W No. 493

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 29<sup>th</sup> day of June, 1965, I found the section corner of sections 28 - 29 - 32 - 33 which was evidenced by a 1½ inch diameter iron pipe at corner location.

Note - Spain, a local surveyor, says this is a good corner.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2 inch inside diameter 5 feet long galvanized steel pipe filled with concrete and capped with a 3 inch diameter bronze tablet stamped
