



## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 8th day of July, 1965, I found the Meander corner of Sections 2 - 35 which was evidenced by remains of a survey by John Curo, Cass County Surveyor in 1915. Iron Monument (found a 2 inch diameter iron pipe marking corner).

Remains of original Government survey of 1873  
Jack Pine 18 inch S82°E 83 links (Now a burned stump at record bearing and distance).

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2 inch inside diameter 5 feet long galvanized steel pipe filled with concrete and capped with a 3 inch diameter bronze tablet stamped
