## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

State of Minnesota,

County of Cass

Peter J. Meyer , being first duly sworn, deposes and says:

That I reside at Cass Lake , Minnesota , and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No.3628

I further depose and say that on the 25th day of September , 1963 , I found the Angle point #3 corner of Sections 2 - 35

which was evidenced by the remains of the GLO resurvey of 1917. Corner was found to be marked by a 1 inch diameter iron post with a brass tablet stamped:

S 35

AP 3

No bearing trees were marked.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new monument set as the GLO brass cap is in good condition.
