

## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 25th day of September, 1962, I found the Quarter corner of Sections 2 - 35

which was evidenced by the remains of the GLO resurvey of 1917. Corner was found to be marked by a 1 inch diameter iron post with a brass cap stamped:

$$\frac{1}{4} \begin{array}{l} S 35 \\ S 2 \\ 1917 \end{array}$$

Jack pine 3 inch S54½°W 86 lks or 56.76 feet (Now a 12 inch Jack pine with scribe "¼ S2B" visible S52°W 56.76 feet.)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new monument set as the GLO brass cap is in good condition.

from which reference or witness monuments are located in the manner following:

Jack pine 11 inch N19°E 18.0 feet MKD ¼ S35 BT

Jack pine 12 inch S52°W 56.76 feet remarked BT

Steel sign post 72 inches long set 24 inches in ground and with standard signs 54-2 and 54-4 attached S89½°E 2.75 feet.
