







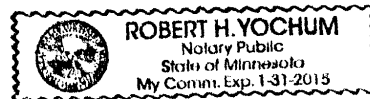

## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Peter J. Meyer, being first duly sworn, deposes and says:  
 That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.  
 I further depose and say that on the 28th day of February, 1963, I found the Center North 1/16 corner of Section 4 which was evidenced by the remains of the G.L.O. Survey of 1917. Corner was found to be marked by a 1 inch diameter iron post with a brass cap stamped:-

Jack pine 10 inch S64-3/4° E 292 links (192.72') (Now a 16 inch red pine at record bearing and distance with scribe overgrown.)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new monument set as the GLO brass cap is in good condition.

Jack pine 13 inch N33°E 9.4 feet marked CN 1/16 BT

Steel sign post 72 inches long, set 24 inches in ground with standard signs 54-2 and 54-4 attached due South 4.2 feet.
